Report on the Audit of the Financial Statements

Opinion

1. We have audited the accompanying financial statements of Taurus Value Steel & Pipes Private Limited (the Company), which comprise the Balance Sheet as at 31 March 2026, the Statement of Profit and Loss (including Other Comprehensive Income), the Statement of Cash Flow and the Statement of Changes in Equity for the year then ended, and notes to the financial statements, including a summary of the significant accounting policies and other explanatory information (herein after referred to as the "Financial Statements").
